

Aircore Drilling Completed at The Claw Gold Project, WA

BPM Minerals Ltd (ASX: BPM) ('BPM' or 'the Company') is pleased to advise that it has successfully completed its Phase 4 Air Core (AC) drilling program at the Claw Gold Project in Western Australia.

84 AC holes were completed for 3,647m over 7 drill traverses during the past month. This campaign targeted ~8km of highly prospective strike, an endowed structure that hosts the Louie and Chickie Prospects.

Next Steps:

- Samples from the drilling campaign have been sent for assay in Perth
- Assay results are expected in early April 2025

This drilling program builds on previous successful campaigns at the Claw Gold Project, including significant gold intercepts at the Louie Prospect such as 25m @ 1.27 g/t Au from 29 meters, including 2m @ 11.63 g/t Au from 29 meters¹. The project's strategic location, immediately south of Capricorn Metals' 3.99Moz Mount Gibson Gold Project², underscores its potential in a proven gold corridor.
