8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
Answer: Further expenditure is expected to be incurred in the near term as the Bankable Feasibility Study (BFS) phase progresses. The Company anticipates a higher level of outflows following completion of the planned capital raising in Q2 of FY2026, which will provide the funding base to advance key BFS workstreams, including engineering design, environmental approvals and drilling to support resource conversion. Accordingly, operating cash outflows are expected to increase in subsequent quarters in line with project development activity.

Answer:

The Company received firm commitments for a \$1.282 million placement in June 2025, with \$424,519 received during the month and the balance expected in the following quarter. The Company will raise additional capital as required and has a strong track record of successfully securing funding when needed.

Answer:

Yes. The Company believes there is ongoing support for future capital raisings, which will allow the Company to continue its activities.
