

THIRD EXTENSION OF THE PROSPECTUS OFFER PERIOD AND CHANGE OF COMPANY CONTACT DETAILS

Eastern Metals Limited (to be renamed “Raptor Metals Ltd”) (ACN 643 902 943) (ASX:EMS) (**Company** or **EMS**) has elected to extend the closing date of the public offer under its Re-compliance Prospectus dated 10 October 2025 (**Offer**) to Wednesday, 17 December 2025, at 7:00pm (AEDT).

The Company extended the Offer on 27 November 2025 to and then on 4 December 2025 to 15 December 2025 at 7:00pm (AEDT) and considers this further extension will allow additional time for investors to apply for EMS shares under the Offer.
