## Corporate Governance Statement

This Corporate Governance Statement is current as at 15 September 2026 and has been approved by the Board of King River Resources Limited (**King River** or the **Company**).

The Company has adopted systems of control and accountability in order to implement and maintain a culture of good corporate governance both internally and in its external dealings.
