

# QUARTERLY REPORT TO 30 SEPTEMBER 2024

## HIGHLIGHTS

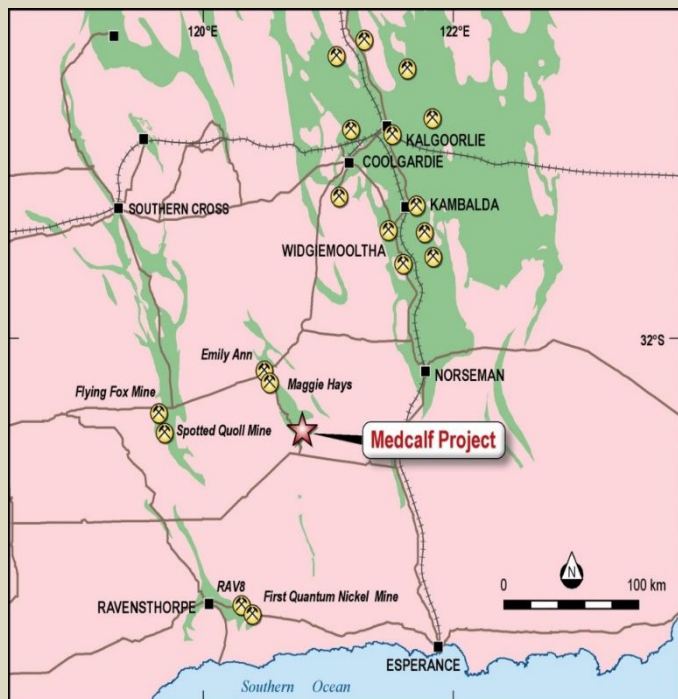
- **Work programs commenced to address conditions of primary environmental approval**

Audalia Resources Limited (ASX: **ACP**) is pleased to present its report for the September 2024 quarter.

### MEDCALF PROJECT

The Medcalf Project is a vanadium-titanium-iron project located some 470 kilometres south east of Perth near Lake Johnston, Western Australia. The Medcalf Project comprises of one granted exploration licence E63/1855, two miscellaneous licences L63/75 and L63/94 and two General Purpose licences G63/10 and G63/12 as well as mining lease M63/656. Together these licences cover a total area of 38 km<sup>2</sup>.

The Medcalf Project lies in the southern end of the Archaean Lake Johnston greenstone belt. This greenstone belt is a narrow, north-northwest trending belt approximately 110 km in length. It is located near the south margin of the Yilgarn Craton, midway between the southern ends of the Norseman-Wiluna and the Forrestania-Southern Cross greenstone belts.

### Environmental Update

During the September quarter, work commenced to address conditions set out in the Ministerial Statement issued under Part IV of the *Environmental Protection Act 1986* (WA) approving implementation of the Medcalf Project. Work programs included flora surveys conducted across the Mine and Haul Road Development Envelopes.

## Project Update

The Company also commenced work required to obtain the remaining regulatory approvals and permits required to support the development of the project, including mining approval for a mining, crushing and screening operation to produce a high grade titanium and vanadium ore to export to the Asian markets.

Audalia continued negotiations with potential offtake partners and potential financiers for company or project level financing.

## CORPORATE MATTERS

The Company had cash and cash equivalents as at 30 September 2024 of \$41,000 (Q4 FY23/24: \$21,000) following payments for capitalised exploration and evaluation expenditure of \$149,000 (Q4 FY23/24: \$92,000) and payments to related parties and their associates of \$38,000 (Q4 FY23/24: \$20,000) during the September 2024 quarter.

Subsequent to the end of the quarter, the Company announced its intention to raise \$2,000,000 by way of placement of 100,000,000 fully paid ordinary shares (**Shares**) in the Company at an issue price of \$0.02 per Share, to a sophisticated investor (**Placement**). The Placement is expected to complete on or around 4 November 2024 and funds will be used to progress the secondary approvals and exploration and evaluation work at the Company's Medcalfe Project and supplement general working capital.

The Board continues to assess all funding alternatives to ensure that the Company can secure the remaining regulatory approvals and permits required to support development of the Medcalf Project.
