

ASX Announcement - 31 October 2024**QUARTERLY REPORT****Period Ended 30 September 2024**

Greenwing Resources Ltd ('Greenwing' or the 'Company')(ASX:GW1) is pleased to provide an update on its activities and progress for the quarter ended 30 September 2024.

During the quarter, Greenwing continued to progress the San Jorge Lithium Brine Project in the Catamarca province of Argentina. The Company having previously tabled a maiden Mineral Resource Estimate for the San Jorge Project completed additional surface exploration programs and additional testing of potential Direct Lithium Extraction (DLE) processing options. In Madagascar the Company continued to progress its portfolio and is encouraged with the continued progress towards enacting the Country's new Mining Code.

HIGHLIGHTS**SAN JORGE LITHIUM PROJECT, ARGENTINA**

- Greenwing has established a strong platform to deliver value from with the establishment of the maiden Mineral Resource Estimate¹ for the project in May 2024, containing 1.07 Mt of Lithium Carbonate Equivalent (LCE) consisting of 0.67 Mt of Indicated Resources and 0.4 Mt of Inferred Resources at an initial grade of 195 mg/L Li in the prolific Lithium Triangle jurisdiction in South America.
- The Mineral Resource Estimate achieved from an initial 6-hole program is characterised by strong specific yield porosities of 7.4 and 7.3% is open in several directions with holes SJDD04 and SJDD05 both ending in mineralisation and target mineralisation.
- In addition to being open depth via SJDD04 and SJDD05 the resource remains open to the west and north, with the recent additional TEM (Transient electromagnetic geophysics) and passive seismic program indicating brine extends to the limits of current exploration.
- The Company continued to assess competing Direct Lithium Extraction (DLE) technologies and analysis of commercial samples was undertaken over the quarter to several potential processing providers.
- The Company continues to plan for additional drilling, progress processing options and seek additional strategic investment.

GRAPHMADA GRAPHITE MINING COMPLEX & MILLIE'S REWARD LITHIUM PROJECT, MADAGASCAR

- Material progress made over the quarter regarding the progression and adoption of the new mining code in Madagascar.
- In addition to the Madagascar Government passing legislation to adopt a new mining code in late 2023. The Mines Ministry of Madagascar issued orders to the Bureau du Cadastre Minier (BCMM) authorising the department to begin the transfer and upgrade of permits to facilitate project development.

- The augmentation of existing mining and exploration regulatory framework in Madagascar is critical to unlocking the considerable potential in Madagascar and will serve to attract additional capital and interest to the country and sector.
- Greenwing along with other listed peers has an established presence in Madagascar and has a considerable portfolio of interests in country.
- With developments underway with the overhaul of mining legislation in Madagascar the Company continued to progress an updated agreement with its partners at the Millie's Reward Hard rock lithium project.
- The Company continued its augur drilling campaign at Andapa and is currently working through a backlog of augur samples ahead of releasing results.

San Jorge Project, Argentina

The San Jorge Lithium Project, located in Argentina's prolific Lithium Triangle, has been the primary focus of the Company's activities over the quarter. Greenwing in addition to holding rights to 100% of the San Francisco Salar has rights to a total consolidated of approximately 38,000 hectares including and surrounding the Salar.

The Company continues to progress the project following the announcement of an initial mineral resource estimate and has a well-articulated strategy to add value to the asset following a successful 18 months.

The Company, in establishing a maiden Mineral Resource Estimate at San Jorge in the June quarter, has put in place a robust foundation to add considerable value to the project and has continued to build on this over the course of the September quarter.

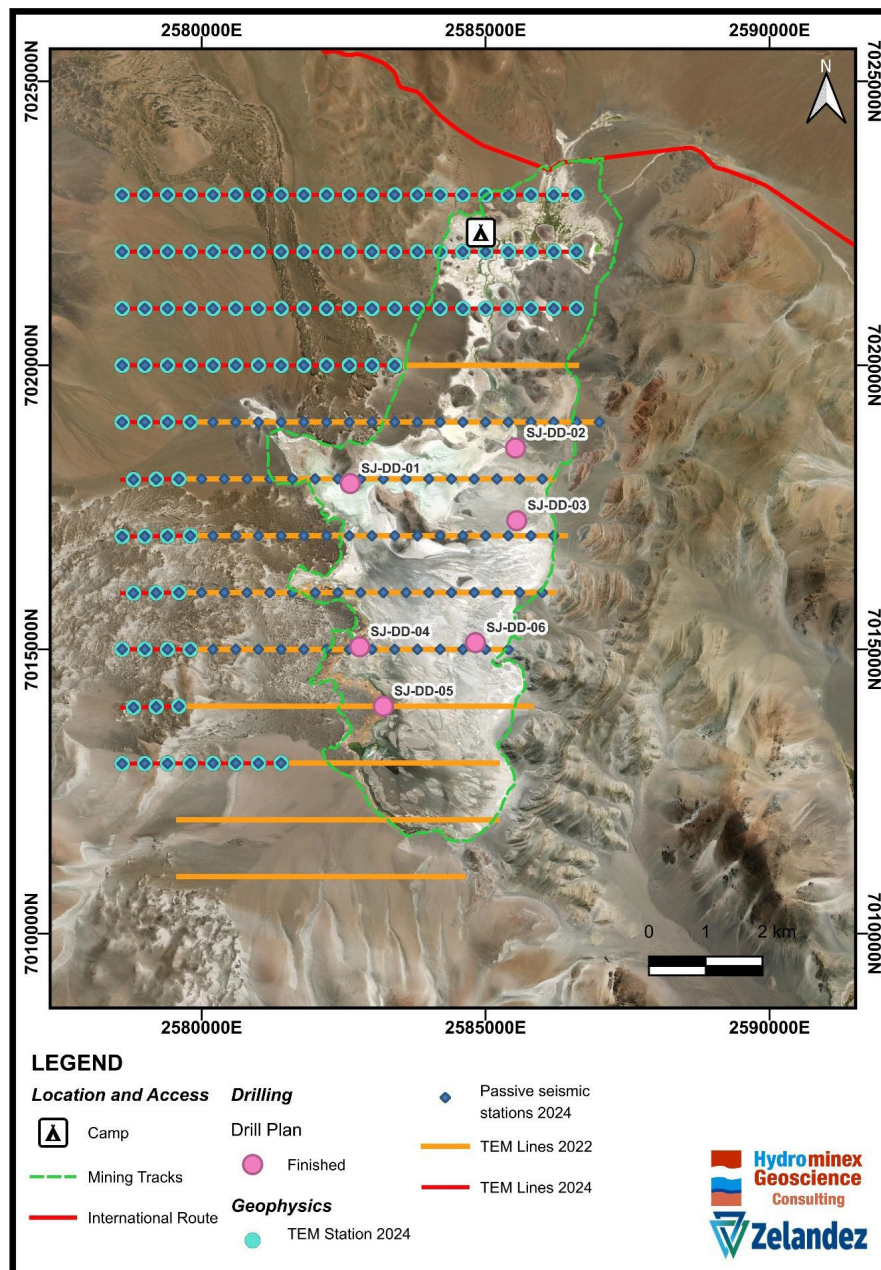


Figure 2: Completed exploration drill holes, passive seismic and TEM geophysics locations within the project area

The initial mineral resource from 6 holes has articulated for the Company an exciting pathway forward to add value post the initial program. The resource characterized by strong porosity measurements is open in several directions including to West and North (see figure 2).

In addition to being open to the West and the North the Company is yet to drill in the middle of the Salar with the first program focusing on the edges of the visible Salar. Of further encouragement the resource remains open at depth with both SJDD04 and SJDD05 ending in mineralization at 402m and 353m respectively.

Over the quarter, the Company completed additional surface work to further refine the geological model and the emerging view that the resource has the potential to extend to the West and North of the visible Salar – refer to ASX announcement dated 11 October 2024.

At this time, pending further drilling, the project is tending towards being a Direct Lithium Extraction process (DLE). The Company has made it a strategic imperative to conduct a thorough appraisal of all available processing technologies. This is a process being overseen by leading global hydrologist and consultant to Greenwing, Mr Murray Brooker.

Testing has been ongoing during the quarter and the Company has received test results from two leading providers of DLE processing technologies, IBC and Xtralit which provided exceptional results which were released to the market on 29 October 2024.

The Resource remains open to the North, West, and at depth with holes SJDD04 and SJDD05 ending in higher concentration brine, with circa 248 mg/L Li at depths of 402 and 351 metres respectively.

With a view to further drilling and validating the Company's view that the brine extends materially in several directions, the company has recently completed an additional TEM (Transient Electromagnetic Survey) along with a passive seismic program that confirms Brine mineralization extending to the North and West to the limits of the surveys. This provides drilling targets with the aim of expanding the resource at the project.

There are a finite number of Salars in the Lithium triangle and fewer again where the company has 100% of the entire salar and surrounding ground. The work done to date gives Greenwing a high degree of confidence that further drilling has the potential to increase the resource numbers at the San Jorge Project substantially having currently completed only 6 of an estimated 24 holes it intends to drill. This drilling revealed the sequence of volcanic derived sediments and volcanics thickens to the west, away from the salar, and that lithium concentrations increase with depth.

Drillhole SJDD04 reached an overall depth of 402 metres, with a continuously mineralized interval from near surface (first sample at 12m) extending to 400 metres, returning an average of 200mg/L Li, 5500mg/l K, specific yield porosities of 10% and a maximum grade of 248 mg/l Li, the highest grade recorded to date. (Refer ASX announcement dated 8 April 2024.)

SJDD05 reached an overall depth of 351m (due to poor hole stability) with brine mineralization remaining open at this depth, with similar lithology being encountered to SJDD04 and a concentration of 246 mg/l in the deepest brine sample.

Note that the potential quantity and grade of the exploration target is conceptual in nature, and there has been insufficient exploration to estimate a Mineral Resource, other than indirect geophysical methods that indicate the presence of an extensive, highly conductive brine body. **It is uncertain if further exploration will result in the estimation of a Mineral Resource in the volumes defined as exploration targets.** Future exploration drilling aims to continue to convert part of the exploration target volume to resources. **Note that insufficient exploration has been conducted to conclude with any certainty that the exploration target could be converted to resources.**

The Company has undertaken planning for a second drilling program of up to 10 holes, including several holes in the middle of the salar, where previous surface samples returned up to 285mg/L Li. It is anticipated that this program could commence in the 2025 financial year.

Madagascar

Overview

The Company retains significant interests in Madagascar including:

- Graphmada Mining Complex
- Andapa Exploration Asset
- Millie's Reward Hard Rock Lithium project

Greenwing has an established presence in Madagascar having been operational in the country since 2016 with the initial acquisition of the Graphmada Graphite project which is currently on care and maintenance.

Greenwing has found Madagascar a good jurisdiction to operate in and sees considerable potential in both the country and its peoples. Greenwing was able to reconstruct and operate the Graphmada Graphite mine over the period from 2016 through to 2020 under the existing legislation.

The Company is encouraged and supportive of the current overhaul of the country's mining legislation and sees the introduction of a new mining code as beneficial for the Company and its operations in Madagascar.

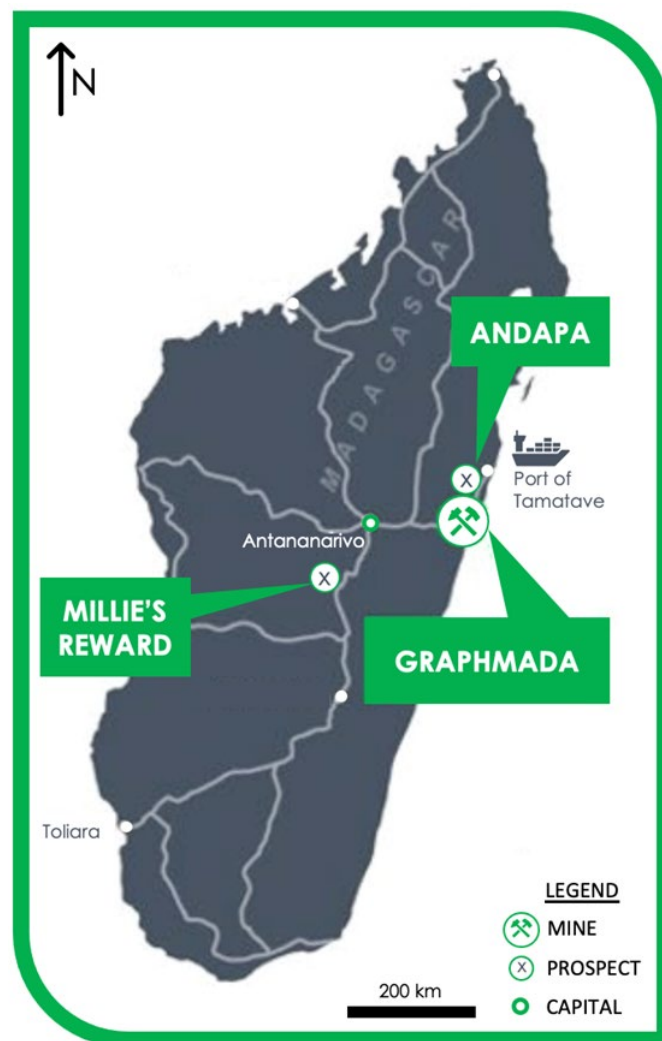


Figure 3 - Locations of Greenwing's projects in Madagascar

Graphmada Graphite Mining Complex.

Graphmada Mining Complex and its infrastructure remain in excellent condition, and the existing Mineral Resource of 61.9 Mt @ 4.5% Fixed Carbon (FC) (refer Table 1) is deemed capable of sustaining substantially higher production volumes.

Greenwing is continuing a process to attract strategic investment and achieve value for its stakeholders for the Graphmada asset given its advanced status.

Graphmada has an existing resource that has produced all commercial concentrates in the graphite complex, with qualification into both the United States and the European Union. These two jurisdictions have classified Graphite as a critical mineral. Additionally, Graphmada has long-life mining leases and considerable infrastructure in place, with the project located just 3 kilometers off the national highway and approximately 120 kilometers from the port of Tamatave (Figure 3).

During the quarter, care and maintenance activities continued on site.

Andapa Graphite Project, Madagascar

Greenwing continued with its auger drilling campaign over the quarter at its Andapa prospect. Andapa is a separate property located a further 60klms towards the country's main deep-water port from Graphmada at Tamatave, Madagascar's second largest city.

The Andapa Project is currently under mining lease.

During the September quarter, the Company completed a further 136 auger holes correlating to 1092m drilled for the quarter. Since the end of the quarter, the drilling program has been completed and the Company is working through processing all samples taken and will be updating the market during the December quarter.

Millie's Reward Lithium Project, Madagascar

Over the September quarter, Greenwing advanced discussions with the vendors of the three permits comprising Millie's Reward project with a view to completing the transfer of these permits to the Company. In parallel with developments with the new Mining Code in Madagascar the Company is seeking to finalise the transfer of tenure and resume exploration activities. The revised mining code in Madagascar aims to ensure timely processing of all mining permit applications. The Company is scheduled to meet with the vendors in Antatarivo Madagascar at the end of November with a view to concluding an updated agreement.

The Company intends to undertake further exploration at the Millie's Reward project following the transfers occurring. This exploration program will focus on completing the soil sampling program over lithium bearing pegmatites, commencing pitting and trenching followed by geophysics to identify potential sub-surface pegmatites.

Millie's Reward is an exciting project characterized by an outstanding surface signature which has identified a large number of pegmatite outcrops along a significant strike length⁶. Additionally, the project has previously returned a weighted average intersection of 3.72% Lithium Oxide over a 31m channel sample⁷.

Previous field programs have identified numerous encouraging rock chip samples up to 7.08% Li₂O and supported by additional samples returning 6.93% and 6.91% Li₂O⁸ and numerous samples between 5-5.7% Li₂O⁹.

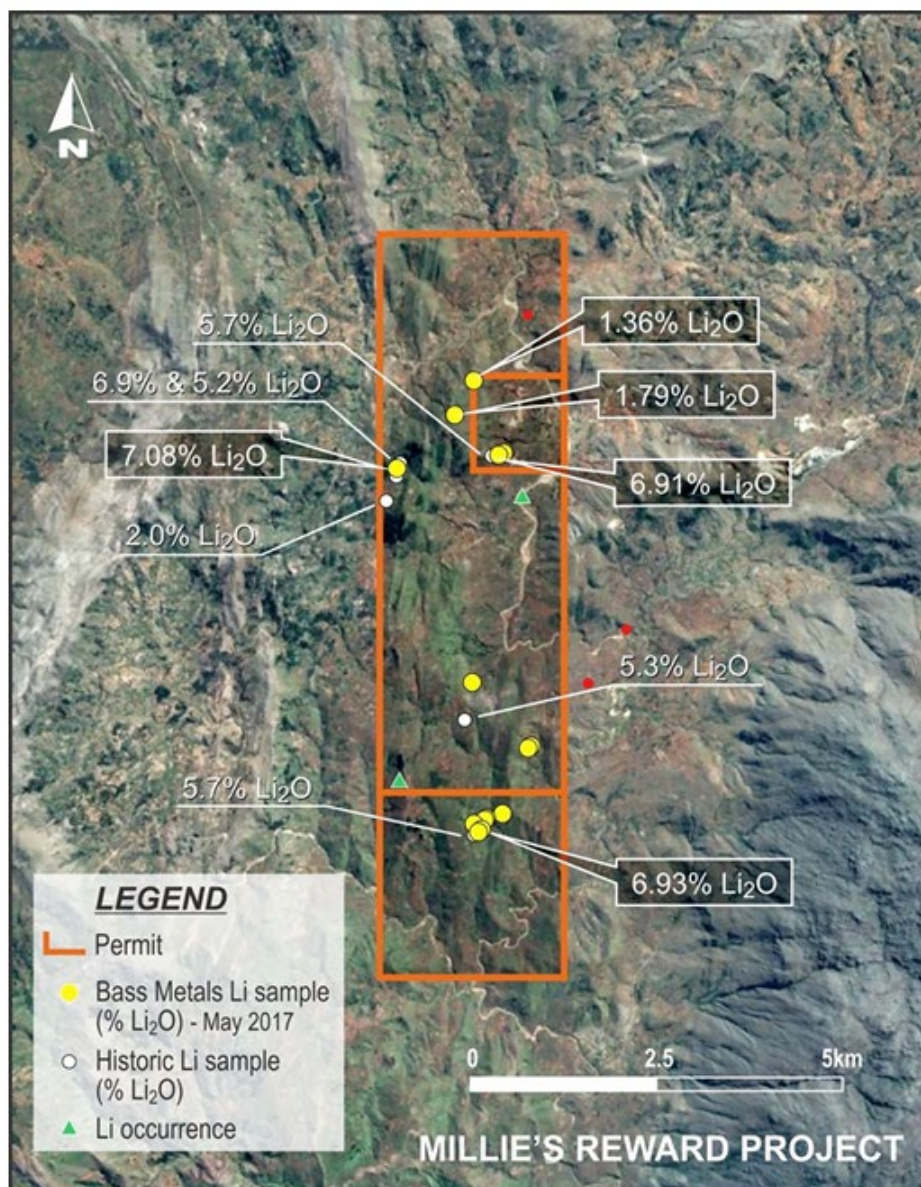


Figure 6 - Millie's Reward Significant Sample Results

Que River - Tasmania

As noted previously, the Company remains in discussions about the potential sale of this asset. The Company continues with care and maintenance activities during the quarter.

Corporate Activities

On 7 August 2024, the Company announced an equity raising totaling \$2.1 million by the issue of additional ordinary shares at a price of \$0.038 per share comprising:

- \$1.4 million from a placement of ordinary shares to professional and sophisticated investors; and
- \$0.7 million from a placement of ordinary shares to professional and sophisticated investors and related parties subject to shareholder approval, including \$0.3m committed by directors.

The raising was well supported by shareholders with all subscriptions coming from existing shareholders. On 26 September 2024, a meeting of shareholders approved resolutions in relation to the equity raising.

On 23 August 2024, a meeting of shareholders approved a resolution to issue shares to the vendors of the San Jorge Project and resolutions in relation to the Company's capacity to issue securities in the future.

On 26 September 2024, the Company released its annual audited financial statements.

ASX listing rule 5.3 disclosures

For the quarter ending 30 September 2024, the Company had net cash outflows of \$217k in expensed and capitalised exploration and evaluation activities.

In addition, exploration and evaluation expenditure activities were undertaken by Andes Litio SA which is not included in the above amount. As noted in the audited annual financial report for the year ended 30 June 2023¹⁰, as a result of the strategic funding transaction with NIO, the Company is considered to have lost sole control of Andes Litio SA (Andes Litio) and even though the Group retains 100% of the shares and voting rights, joint control exists as decisions about the relevant activities of the San Jorge Project require unanimous consent of the parties. Accordingly, the Company's interest in Andes Litio is recognised as an interest in a jointly controlled entity and is accounted for under the equity accounting method.

Under this accounting treatment, any funds provided to, or expenditure incurred by the Company in relation to, Andes Litio are reported as an increase in the investment in Andes Litio in the cash flow statement. For the September 2024 quarter this amount was \$355k (previous quarter \$1,880k) reflecting the exploration activities undertaken during the quarter.

Also, any cash held by Andes Litio is not recognised as cash on hand for Greenwing at the end of the period in the cash flow statement. As of 30 September 2024, a further \$85k is held by Andes Litio, which will be utilised for in-country exploration and associated expenses.

The total amount paid to directors of the entity and their associates in the period (item 6.1 of Appendix 5B) was \$103k relating to prior quarters, with an amount of \$35k accrued for the quarter.
