

NOTICE PURSUANT TO SECTION 708A(5)(E) OF THE CORPORATIONS ACT

Lindian Resources Limited (ASX:LIN) ("the Company") gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 Cth ('the Act') that on 14 October 2025, it has issued a total of 1,723,595 fully paid ordinary shares relating to the conversion of options exercisable at \$0.30 on or before 9 December 2025.

 - ii. the rights and liabilities attaching to the Shares.
