With regards to the proposed issue of Performance rights - the terms are as follows:

Class A Performance Rights: 750,000 Performance Rights will vest and become exercisable upon the Company raising a cumulative additional \$3,000,000 of capital in support of its current or additional projects within two years of the appointment as CEO;

Class B Performance Rights: 125,000 Performance Rights will vest and become exercisable on the 12-month anniversary of the appointment as CEO; and

Class C Performance Rights: 125,000 Performance Rights will vest and become exercisable on the 24-month anniversary of the appointment as CEO.
