

2025 CORPORATE GOVERNANCE STATEMENT

Orpheus Uranium Ltd (the **Company**) is committed to having the highest standards of ethical behaviour and an effective system of corporate governance for the Company, commensurate with the size of the Company and the scope of its business operations.
