

Issue of Shares and Cleansing Notice

Further to the ASX announcement on 26 September 2023, Perpetual Resources Ltd ("**Perpetual**", or "**the Company**") (ASX: **PEC**) issued 5,000,000 fully paid ordinary shares ("**Shares**") on 28 September 2023 as part of the consideration for acquiring permits for the Itinga & Paraiso Prospects in Minas Gerais, Brazil.

Cleansing Notice

Perpetual issued the first tranche of Shares without disclosure to investors under section 708A(5) of the *Corporations Act 2001* (Cth) ("**Act**"). With reference to the Shares issued, in accordance with section 708A(6) of the Act, the Company gives notice under paragraph 708A(5)(e) that:
