Answer:	
The Company has been able demonstrate a record of securing funds when required and is confident that it will be to continue to do so upon ongoing satisfactory exploration results. An announcement was made to the ASX on 26 June 2023 with a planned entitlement issue of \$1.89m. In addition, an announcement was made to the ASX on 26 June 2023 confirming the sale of Ragnar Metals Sweden AB to BHP for A\$9.8m. The Company confirmed completion of the sale on 19 October 2023.
