NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 (CTH)

On 21 October 2025, QX Resources Limited (**Company**) issued 13,889 fully paid ordinary shares in the capital of the Company following the conversion of 13,889 unlisted options exercisable at \$0.01 each (**Option Conversion Shares**).
