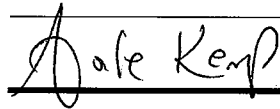

DIRECTIONS

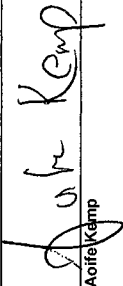
