PACGOLD LIMITED: REQUEST FOR TRADING HALT

Pursuant to Listing Rule 17.1, Pacgold Limited (ACN 636 421 782) (ASX: PGO) (PGO) requests a trading halt be granted by the Australian Securities Exchange (ASX) in respect of PGO's securities immediately.
