CLEANSING NOTICE UNDER SECTION 708A(5) OF THE CORPORATIONS ACT 2001 (CTH)

SQX Resources Limited (ASX: SQX) ("**SQX**" and "**Company**") advises that it has issued a total of 7,812,500 fully paid ordinary shares at \$0.10 per share. Further details are set out in the Appendix 2A lodged today and the Company's ASX announcement dated 16 October 2025. The Company gives this Notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act) for this issue.
