Notice of Annual General Meeting and Proxy Form

Your proxy voting instructions must be received by no later than 11:00am (WST) on Monday, 17 November 2025, being not less than 48 hours before commencement of the Meeting. Any proxy instructions received after that time will not be valid for the Meeting.

All resolutions at the Meeting will be voted on by poll.

Shareholders are strongly encouraged to either vote prior to the Meeting or to appoint the Chair as their proxy.
