This is a corrective announcement following a reconciliation of First Graphene's records. Shareholders approved the issue of 6,000,000 unlisted options to Ord Minnett Limited (ABN 86 002 733 048) and Foster Stockbroking Pty Limited (ABN 15 088 747 148) at their General Meeting held on 18 June 2025.

Prior to the General Meeting, 6,000,000 Unlisted Options was granted by the Company under its placement capacity afforded under the Listing Rule 7.1.
