REQUEST FOR TRADING HALT

Pursuant to Listing Rule 17.1, Vulcan Energy Resources Limited (ASX: VUL) (**Vulcan or the Company**) hereby requests that the securities of the Company be placed into a trading halt with immediate effect.

The trading halt is requested pending an announcement to the market in relation to Vulcan's Phase One Lionheart Project financing, including a pro rata accelerated non-renounceable entitlement offer (**Entitlement Offer**) and institutional placement (**Placement**).

Vulcan requests that the trading halt remains in place until the earlier of the commencement of normal trading on 5 December 2025 or until the release of an announcement in relation to the outcome of the institutional component of the Entitlement Offer and the Placement.

The Company is not aware of any reason why the trading halt should not be granted nor any other information necessary to inform the market about the trading halt or that ASX asks for.
