This Corporate Governance Statement is current as at 15 September 2023 and has been approved by the Board of the Company on that date.

The board of directors of Perpetual Resources Limited ("PEC") is committed to conducting the Company's business in accordance with the highest standards of corporate governance. The board is responsible for the Company's Corporate Governance and the governance framework, policy and procedures, and charters that underpin this commitment. The board ensures that the Company complies with the corporate governance requirements stipulated in the *Corporations Act 2001* (Cth), the ASX Listing Rules, the constitution of the Company and any other applicable laws and regulations.

The Company has adopted a Corporate Governance Plan which provides the written terms of reference for the Company's corporate governance duties and is available on the Company's website at <https://www.perpetualresourceslimited.com.au/corporate-governance>

Due to the current size and nature of the existing Board and the magnitude of the Company's operations, the Board does not consider that the Company will gain any benefit from individual Board committees and that its resources would be better utilised in other areas as the Board is of the strong view that at this stage the experience and skill set of the current Board is sufficient to perform these roles. Under the Company's Board Charter, the duties that would ordinarily be assigned to individual committees are currently carried out by the full Board under the written terms of reference for those committees.
