Issue of cleansing notice under section 708A(5)(e)(i) of the Corporations Act 2001 (Cth)

This notice is given by C29 Metals Limited ("**C29**" or the "**Company**") under section 708A(5)(e) of the Corporations Act 2001 (**Act**).

Further to the Appendix 2A released today, a total of 13,400,000 fully paid ordinary shares (**Shares**) were issued as a result of tranche 1 of the placement.

Secondary Trading Notice Pursuant to Section 708A(5)(e) of the Corporations Act 2001 (Act)

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, a sale of the Shares noted above will fall within the exemption in section 708A(5) of the Act.

- c) as at the date of this notice, other than as set out below, there is no information that is 'excluded information' within the meanings of section 708A(7) and 708A(8) of the Act.
