Answer: No. The Company undertook a cut back in the existing pit during the quarter which resulted in an increase in mining costs. These costs are no anticipated to continue in coming quarters.

Answer: The Company raised approximately \$22.5m as announced on 21 November 2024, and believes this provides the Company with sufficient funds moving forward, noting the expected reduction in expenditure as outlined in section 8.8.1 above.
