29th Copper Concentrate Shipment Dispatched

Perth, Australia: Alara Resources Limited (ASX: AUQ) (**Alara** or the **Company**), a base and precious metals producer and explorer with projects in Oman, is pleased to announce the dispatch of the 29th shipment of copper concentrate from its Al Wash-hi -Majaza copper-gold mine in Oman. The Al Wash-hi - Majaza mine is operated by Alara's joint venture company Al Hadeetha Resources LLC (**AHRL**). Alara holds a 51% interest in AHRL.

Key Highlights

- **29th shipment of 1995.4 WMT copper-concentrate shipped on 16th November, comprising 363 MT copper and 3.7 Kg gold**

The Al Wash-hi Majaza copper-concentrate plant has achieved a production of 1995.4 WMT of copper-gold concentrate with approximately 363 MT of contained copper and approximately 3.7 kg of gold in its latest shipping cycle. This comprises the 29th parcel of copper-concentrate exported from the plant, and departed Sohar Port on 16th November.
