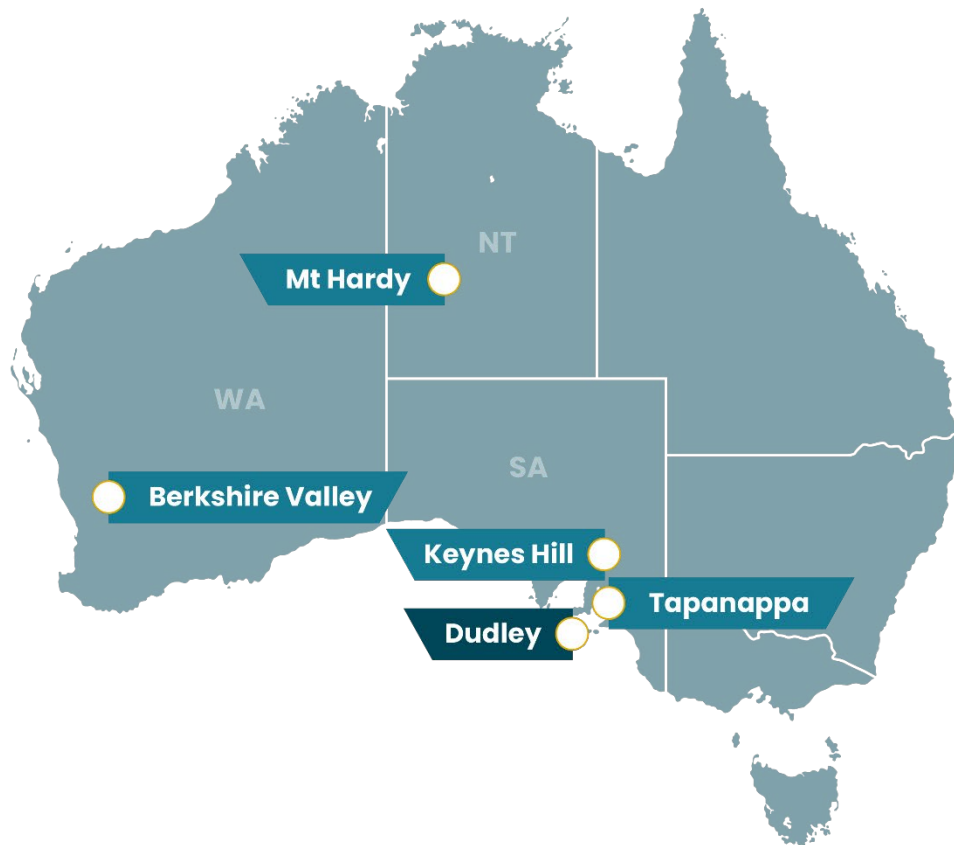

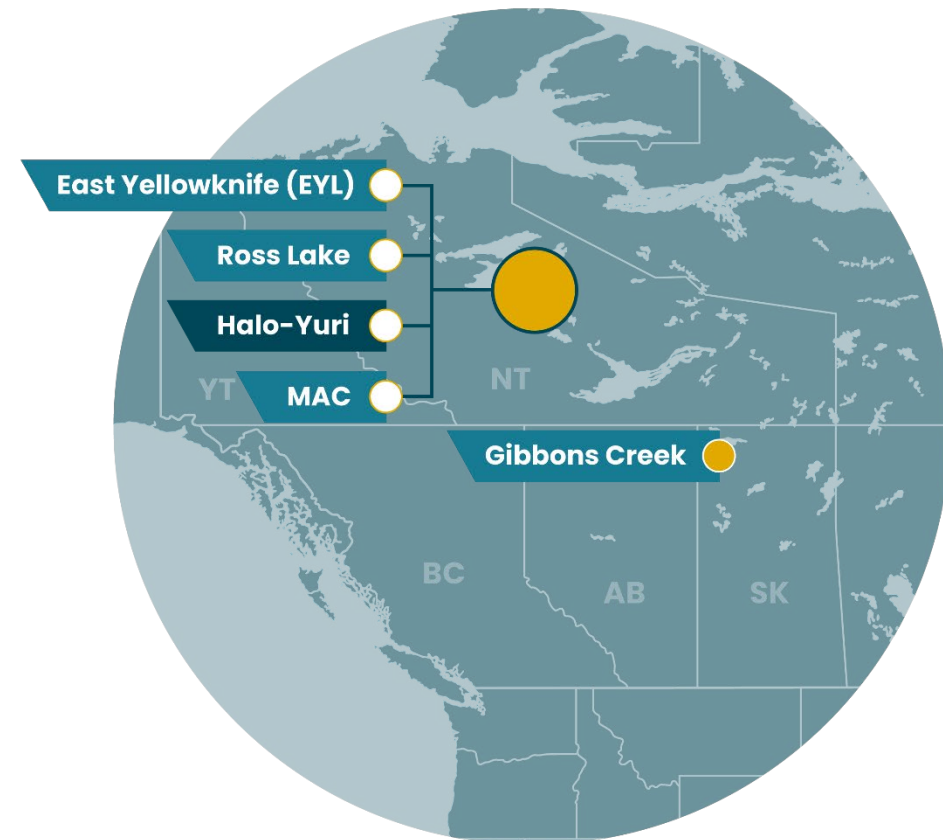

Dudley Lithium Project

Dudley Lithium Project, Kangaroo Island, South Australia

- Dudley pegmatite (main focus) is located close to infrastructure and transport links.
- Project is 100% contained within freehold farming paddocks.
- Kangaroo Island was host to several historic mines operating through the 1900s.
- State government support to regulate the coexistence of mining and nature-based tourism.
- Supportive Landholders.



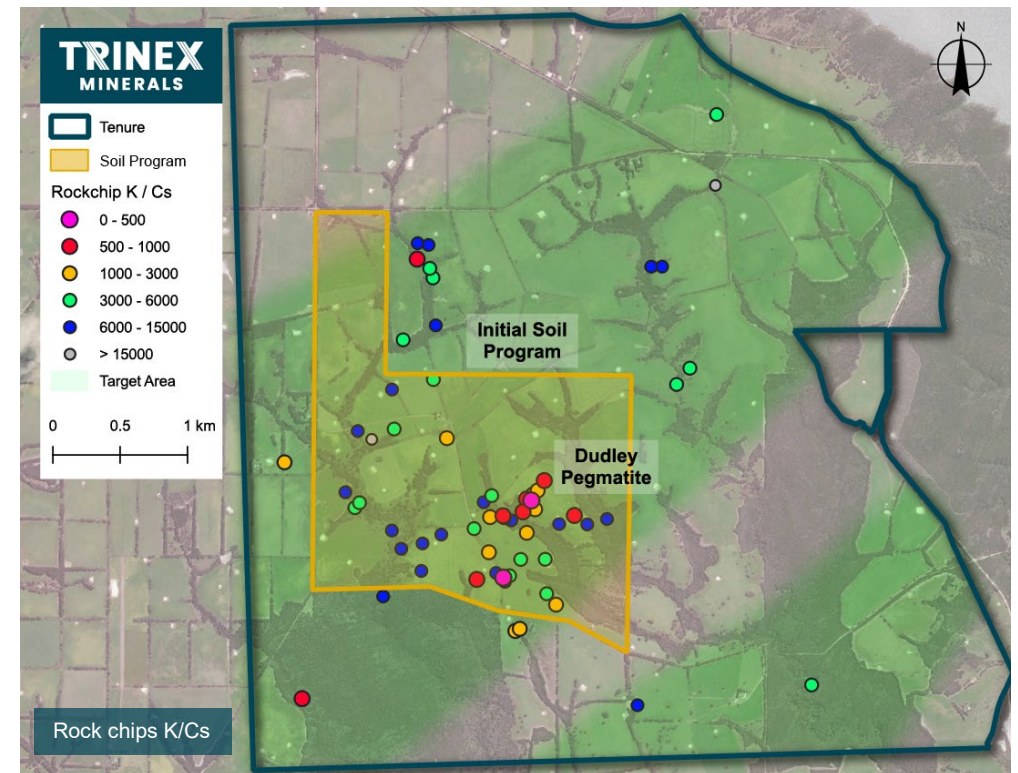
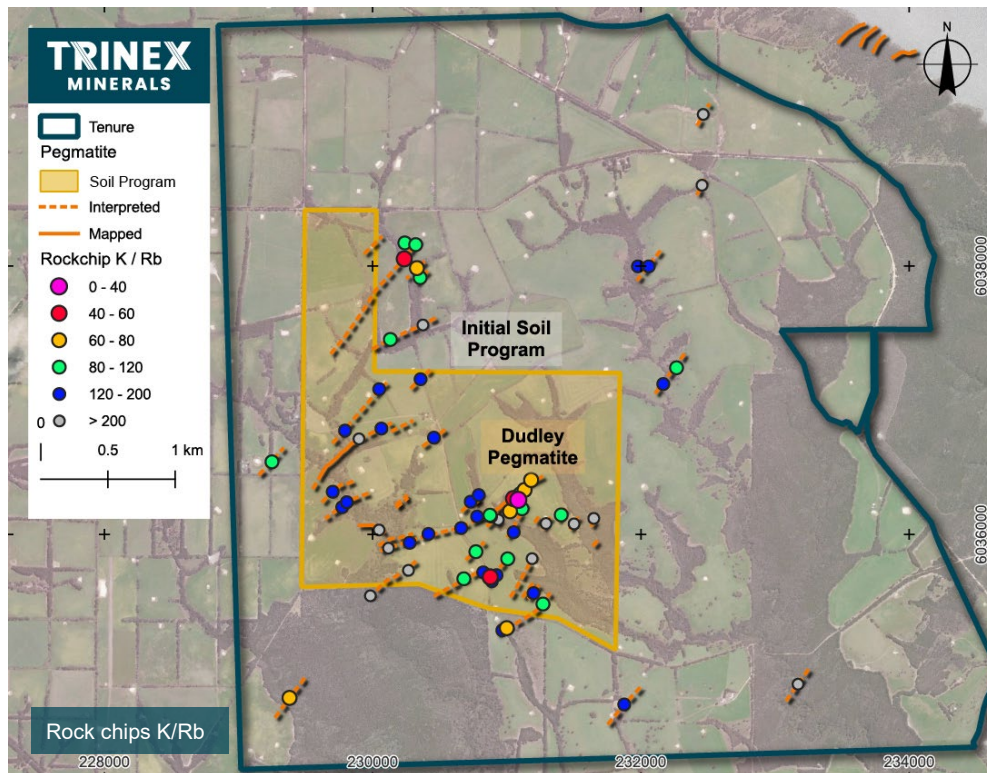
Dudley Pegmatite: Exploration History

- Early exploration around the Dudley pegmatite focused solely on gem quality lithium tourmaline.
- Around 20 shallow trenches were completed to a maximum depth of 1.8m which exposed the weathered pegmatite across a thickness of up to 80m.
- Image on right from 1987 shows a trench across pegmatite – highly weathered clay/soil at surface.
- Exploration and trenching work focused only on the main pegmatite and ignored multiple parallel pegmatites across the project.



Historical Rock Chip Results

- No historic drilling, limited rock chip sampling completed.
- High fractionation and associated lithium prospectivity indicated by results: Rb (>500ppm), Cs (>50ppm), Ta (>20ppm).
- Pegmatites sampled across 10x5km zone.

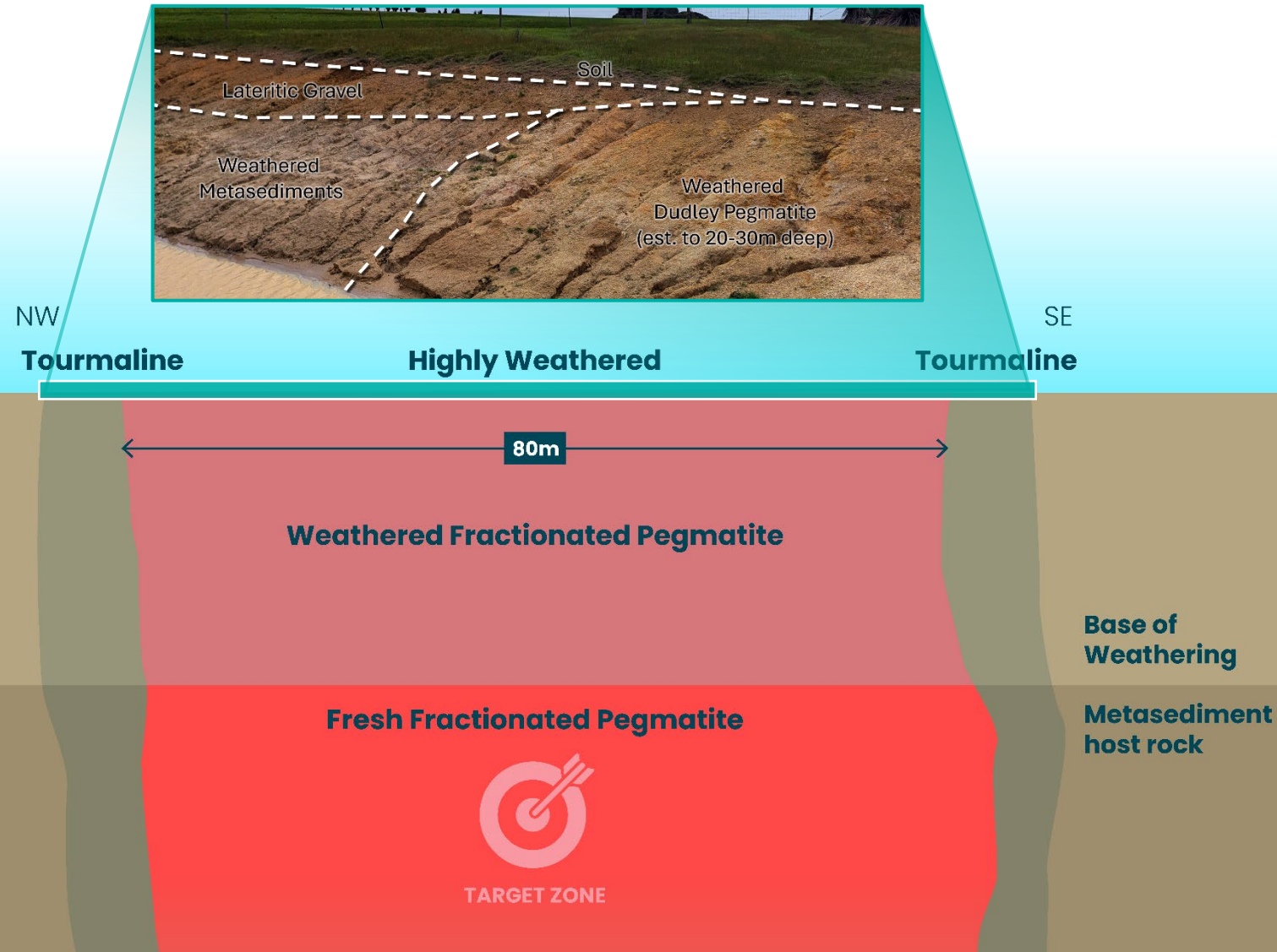

Dudley Pegmatite: Schematic Exploration Model

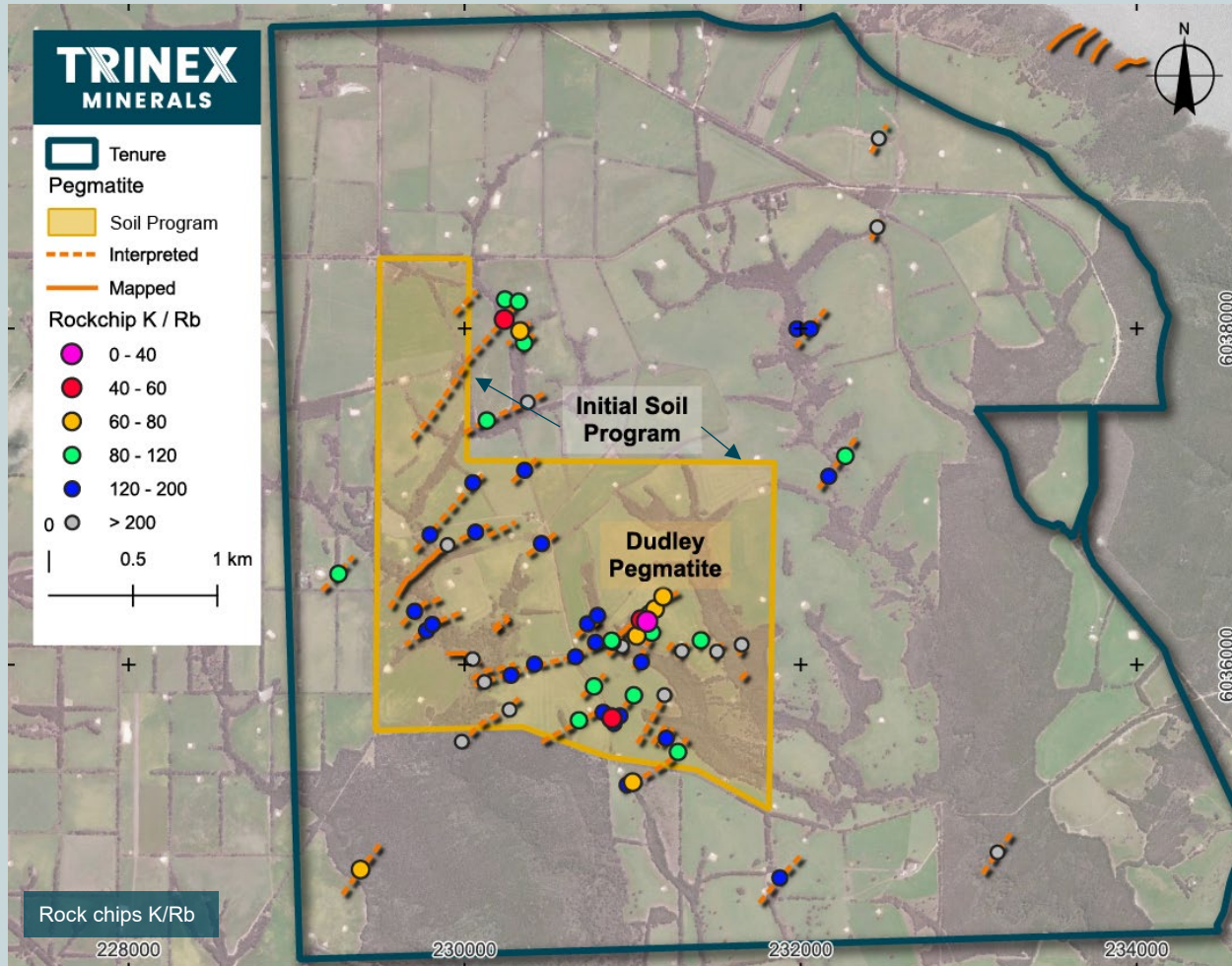
(not to scale)

- Depth of weathered profile estimated to be 20-30m based on government RAB drilling along roads.
- Spodumene unlikely to have survived in this environment hence no surface expression.
- Similar profile to that seen at Greenbushes.
- Lithium tourmaline more resistive and found on the margins of the weathered pegmatite.
- Initial RC drilling will target the thickest parts of the Dudley pegmatite immediately below this weathered profile.

Proposed Work Plan



- Soil sampling and analysis for Mobile Metal Ions (MMI) is almost complete – designed to define the limits of the pegmatites through pathfinder minerals.
- Concurrent mapping and rock chip sampling across the Project is identifying previously unknown additional pegmatites.
- It is anticipated a short RC drilling program will be implemented once the required statutory approvals are in place (expected December 2024).

Loyal Lithium [ASX: LLI]

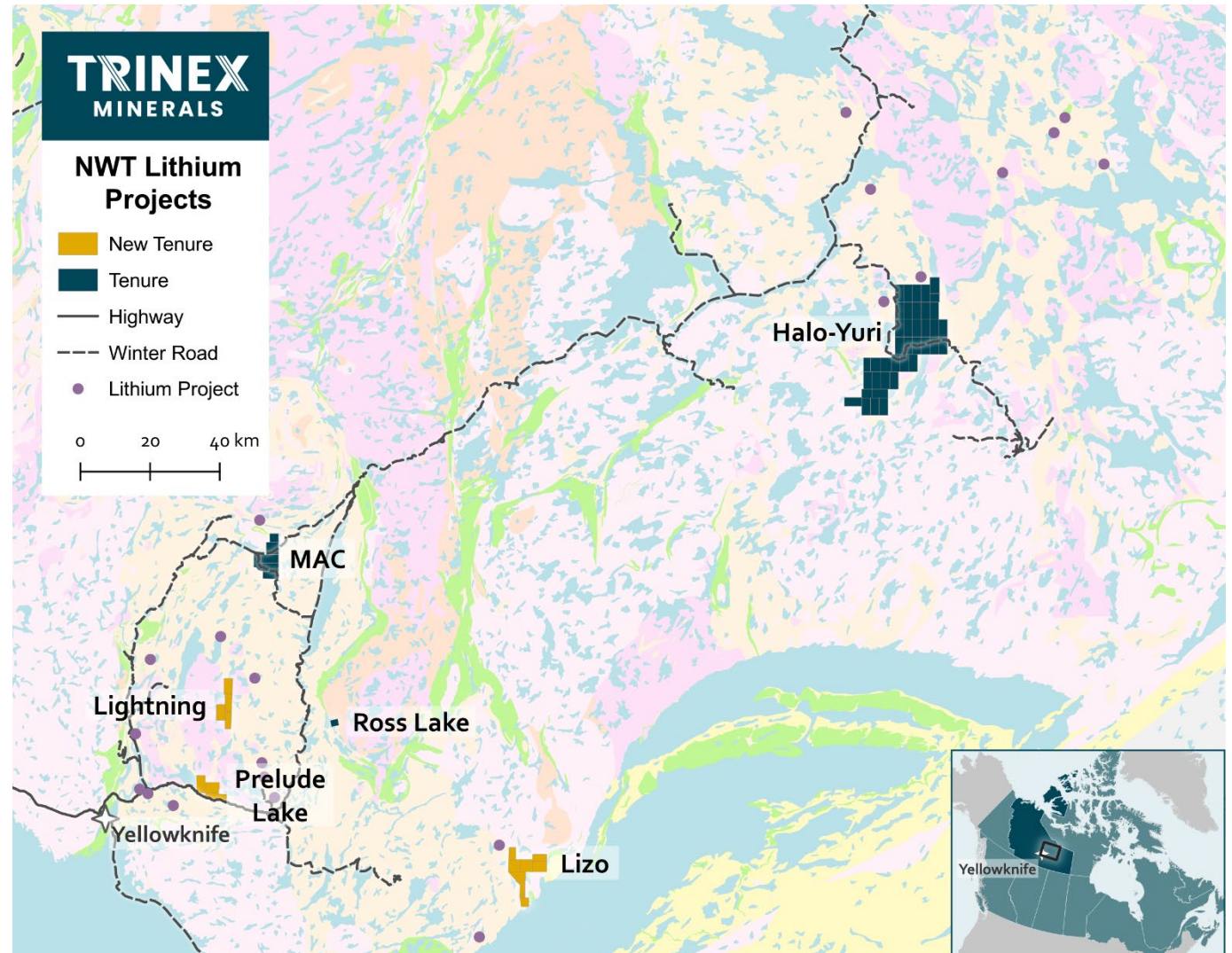
- Hidden Lake Lithium Project acquired April 2023.
- 14 Lithium bearing pegmatites present across project –only 4 drilled.
- Pegmatite mineralisation identified of 3,250m. (LLI ASX: 19 Oct 23)

Midas Minerals [ASX: MM1]

- Exploration underway at Aylmer Li Project with 17 spodumene-bearing pegmatites over 4km of strike (MM1 ASX: 10 July 2024).
- Reid-Aylmer “Argus” pegmatite (30m x 450m) returned a channel sample of 26m at 1.27% Li_2O , including 12m at 1.75% Li_2O (MM1 ASX 27 August 2024).

Li-FT Power [TSXV: LIFT]

- Yellowknife & Cali Lithium projects with thick high grade Li intersections in drilling.
- Drill hits include 60m @ 1.38% Li_2O and 56m @ 1.42 Li_2O (LIFT TSXV: 12 Aug 23). MRE of **50.4Mt at 1.00% Li_2O** (LIFT TSXV 1 Oct 24)



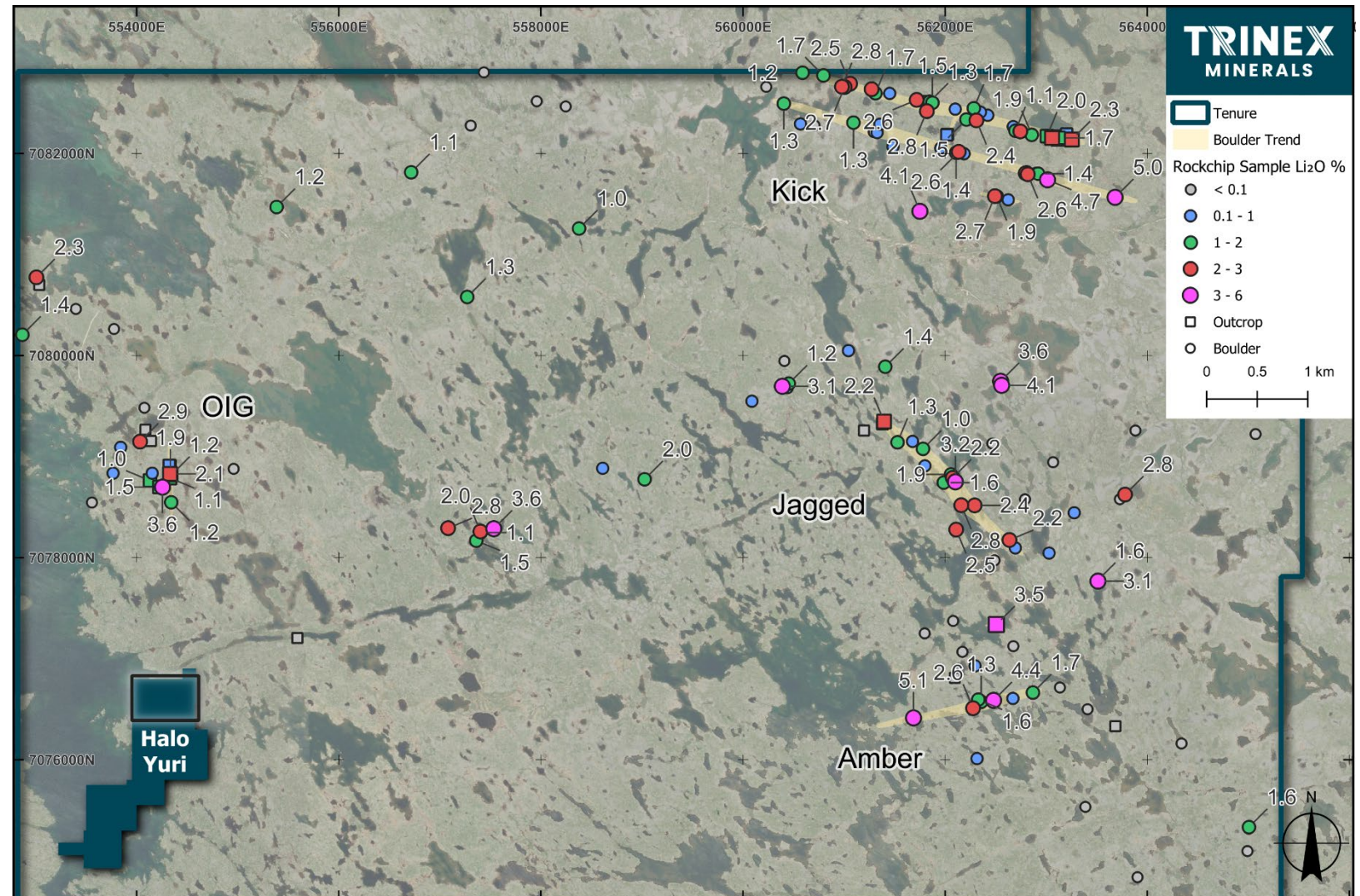
Halo-Yuri Lithium Project Overview

- Widespread mineralisation confirms potential for significant lithium resource.
- High-grade rock chips from multiple prospects across the project, results up to 4.1% Li_2O .
- Spodumene is confirmed as the lithium bearing mineral.

Halo-Yuri Lithium Prospects

Kick Prospect:

- Two parallel, WNW-ESE striking 3km trends with widespread lithium mineralisation.
- Northern trend has abundant mineralised boulders with Li_2O rock chip values up to 5%.

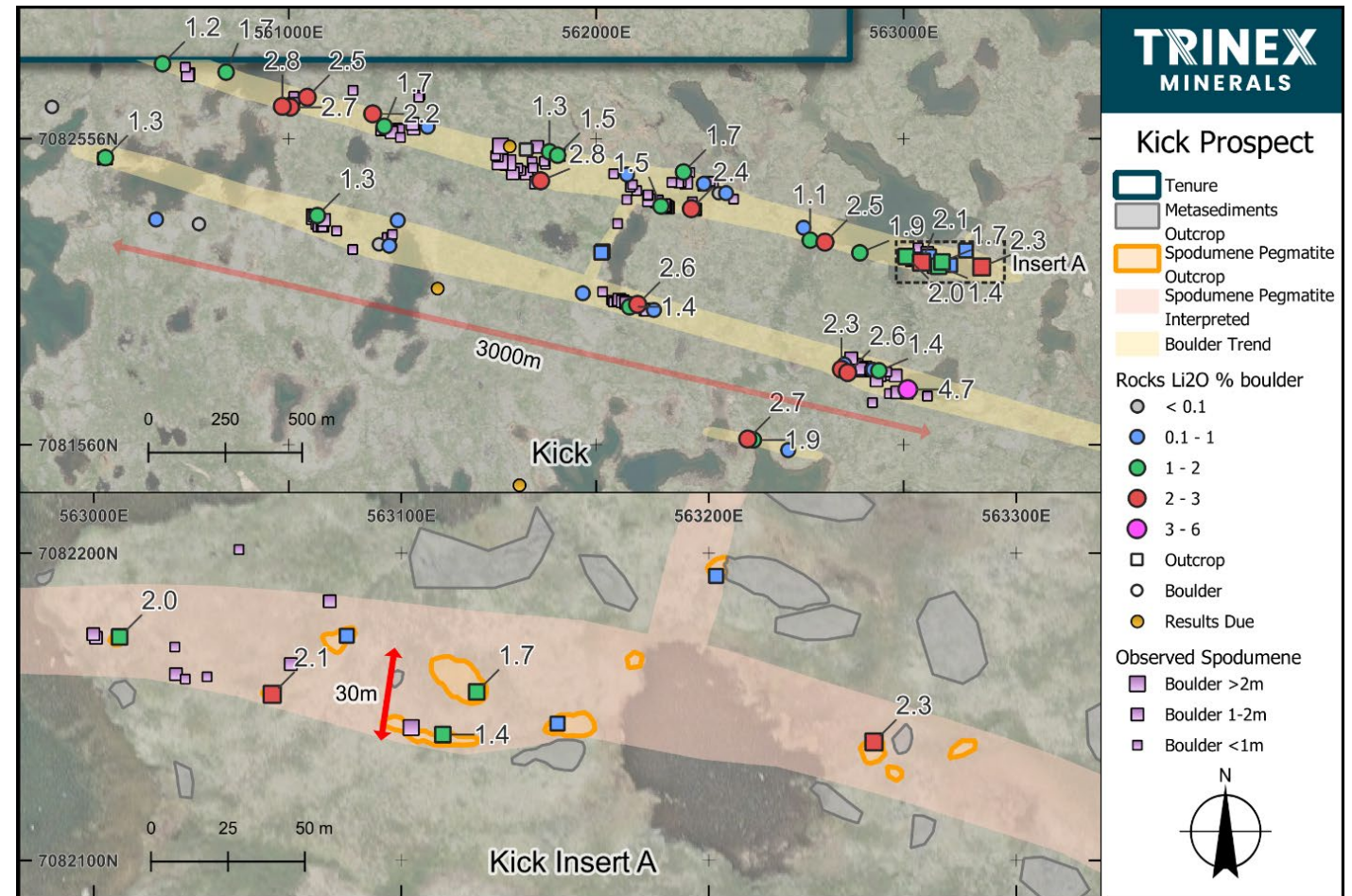
Jagged Prospect:

- Large mineralised boulders in NW-SE 2.6km trend.
- Assay values up to 4.1% Li_2O .

OIG Prospect:

- Historic pegmatite previously sampled.
- High-grade assays up to 3.6% Li_2O from boulders and 2.0% Li_2O from outcrop.

Less than 15% of the prospective northern area was covered by TX3 detailed mapping, giving credibility to the potential of the area to host a significant lithium resource.

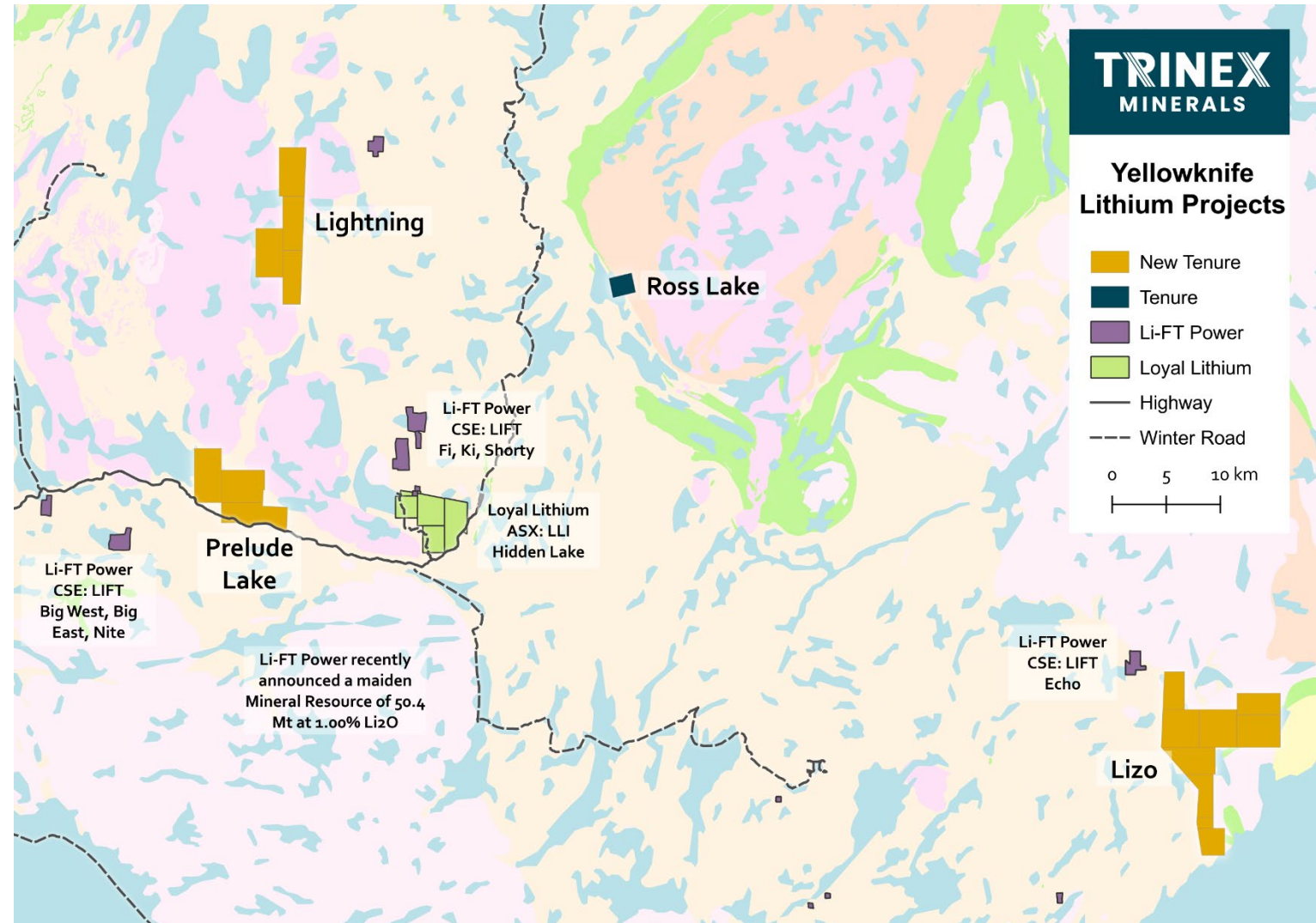

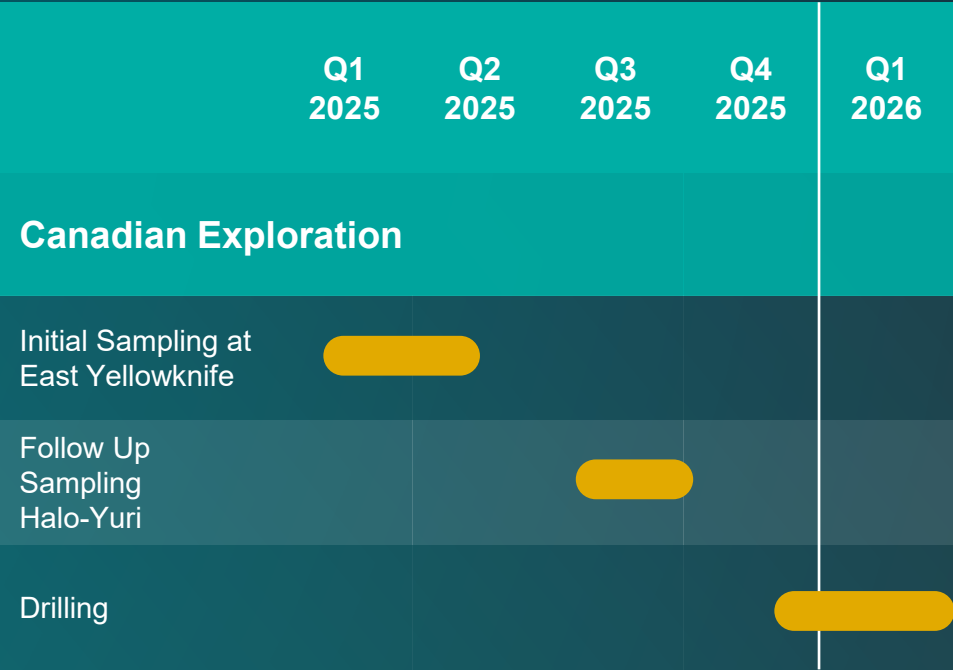

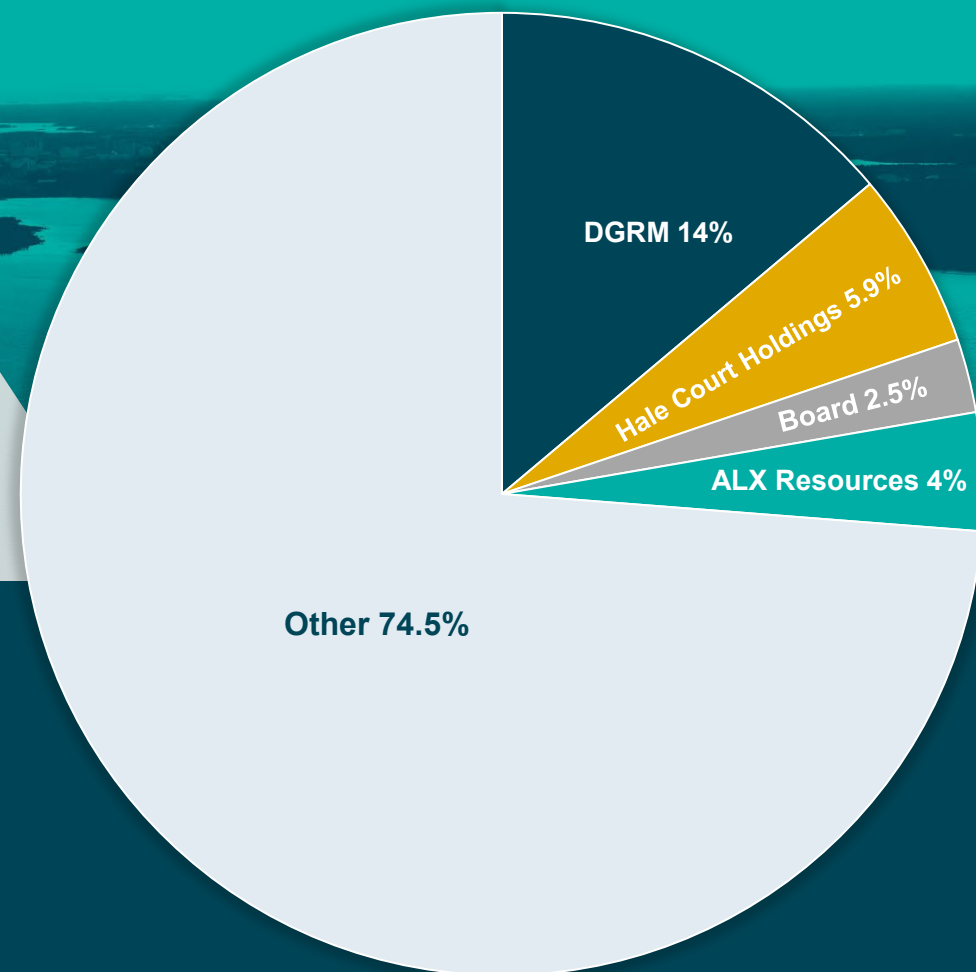
